NOTICE IS HEREBY GIVEN to all owners of lands located within the boundaries of the NORTH PALM BEACH HEIGHTS WATER CONTROL DISTRICT: The annual landowners' meeting shall be held on Wednesday, November 28, 2018, at 6:00 P.M. at the Jupiter Branch of the Palm Beach County Library, 705 Military Trail, Jupiter, Florida 33458. The annual election of a Supervisor shall be held and one Supervisor shall be elected for a three year term with the Board Seat of Lynn McCullough becoming vacant due to expiration of term of office. Written ballots may be cast by landowners at said election either in person or by proxy. Nominations for said office may be made by landowners at the meeting. The District shall hold a regular business meeting for the month of November immediately following the Landowners' Meeting.

If a person decides to appeal any decision made by the Board with respect to any matter considered at this meeting, he or she will need a record of the proceedings and, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is based.
